**Travel lift 100t**

- Lifting must be ordered at least 3 days in advance.
- Lowering must be ordered at least 1 day in advance.
- For services on Sundays, holidays or outside working hours the price will be increased by 100%.
- For lifting, lowering and HP hull wash of catamarans the price will be increased by 50% on the lenght price.
- For vessels that are lifted from or lowered on means of road transport (trucks, trailers) a 50% surcharge is calculated on the price of lifting/lowering, according to the length of the vessel.

**Other**

- Lifting or lowering of jet ski and tender up to 4m. Price 40 EUR. Underwater hull wash Price 15 EUR.
- Separate washing of the vessels propulsion will be cahrged in the amount of 50 % of the high presuure hull wash on the length price.
- The service of mast lifting and lowering is not provided.
- If the vessel exceeds the max. beam in regard with the LOA category, it will be automatically classified into the next category
- One Evironmental tax of 3 EUR per vessels length will be charged upon arrival to the service in the shipyard Brodogradiliste Punat.

**DISCOUNTS:**

- In the winter period from 01.10. to 28.02. the prices for lifting or lowering on Travel lift 100t are reduced by 30% for holders of annual contracts with Marina Punat d.o.o. Discounts do not add up.

## SERVICE STORAGE FOR VESSELS ON LAND/SEA - NOTES

Service storage of vessels on land or at sea while the workers hired by the shipyard Brodogradilište Punat d.o.o. perform the works is not charged, unless otherwise defined in the offer.

In case of need for additional work, and in cases of need for additional parts where the supplier is the Shipyard Punat, and the delivery period is longer than 7 days, the first seven days of service storage are not charged. All remaining days of service storage are charged according to the valid price list. In cases where additional parts and materials are purchased by the client/owner of the vessel, all days of service storage will be charged.

## INFRASTRUCTURE USAGE BY SUBCONTRACTORS:

In Brodogradilište Punat d.o.o. it is not allowed to perform any kind of works without work permission. Work permission can be obtained on the Yacht Service reception desk, with the previously announcement and verification and is valid only in period for which is issued. The basis for payment of such permission is usage of infrastructure Brodogradilište Punat, which include:

- Entry and exit permission, during the time of work permit validity
- Connection and consumption of electricity up to 16 A and water
- Usage of plateau and piers for boat access
- Disposal of technologic and domestic waste (cleaning of the work area not included!)
- Usage of sanitary facilities

Preconditions for acquiring work permission are:

- a) Request with the name of the vessel, a detailed description of the work to be performed and the period service performance.
- b) Power of attorney of the vessel owner in written form, in which the subcontractor is allowed to carry out work on the owner's vessel.
- c) Certificate of company or trade registration with a list of registered activities
- d) Business liability insurance policy.
- e) List of employees who will perform the work and copies of identity cards.

The request for the issuance of a Daily Permit for the use of the infrastructure must be submitted in writing at least 3 days in advance. The request is sent to the e-mail address yacht-service@marina-punat.hr. The Shipyard Punat reserves the discretionary right to accept or reject requests. The cooperative guarantees the work and safety of its workers. He may not perform services for which he has not received a work permit.

## GENERAL NOTES:

For services that are not quoted in this Price list, please contact Brodogradilište Punat d.o.o.

By renting a daily moorage, the berth should be left by 2 p.m. on the last paid day.

The owner of the vessel should supply the ropes from boat to the anchor and from boat to the pier.

Please keep the work area clean while carrying out repair-works and clean it completely before leaving. If the work area is not cleaned, 500 EUR will be charged for cleaning of the work area. In the case of environmental pollution, all incurred remediation costs will be charged to the person/company that caused the damage.

Length over all and width over all is taken into consideration. Tender of the vessel is a vessel with length over all up to 4 meters.

**All clients of Brodogradilište Punat d.o.o. are kindly asked to abide the Rules of the harbour, Trading conditions of Brodogradilište Punat d.o.o. and Regulation for establishing a subcontracting relation.**

Works in Shipyard Punat are allowed only to the boat owners or their registered crew and registered subcontractors. Registered subcontractors are companies which have an authorisation and permission to work in the Shipyard Brodogradilište Punat d.o.o.

All work is strictly prohibited in which there is an increased risk of damage to neighboring vessels and/or property of the Shipyard and/or property of third parties: washing with a HP washer (pump); using a compressor and syringe and other devices for applying paint, varnishes, gel coat, etc. by spraying; sawing, grinding the outer surfaces of the vessel without the use of tools with a vacuum cleaner attached; welding, etc. All work on systems or parts (equipment) of the fuel or gas system, as well as manipulation (filling, pumping, transferring, etc.) with fuel or gas is strictly prohibited, except for companies that are registered for the operation/servicing of said systems/parts of the system and which they have concluded a subcontracting relationship with the Shipyard or perform work at the invitation of the Shipyard.

Starting with application of this price list, the former price list is no longer valid.

The ordering party is taking possession of charge duty. Rented assets and equipment are used at own responsibility.
